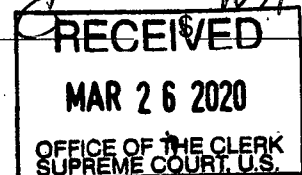


**AFFIDAVIT OR DECLARATION


