

ORDER APPOINTING COUNSEL AND SETTING BRIEFING SCHEDULE

This matter is before the Court on Defendant's *pro se* Motions for modification or reduction of sentence under the First Step Act of 2018 (FSA) (ECF Nos. 85, 88), as well as Defendant's Motion to appoint counsel. (ECF No. 89.) The Government has filed a response and Defendant has filed a reply. Defendant may, or may not, be eligible for a reduced sentence under the FSA. The Court determines that Defendant should have counsel appointed to address the impact, if any, of the FSA on Defendant's sentence.

Therefore,

IT IS HEREBY ORDERED that Defendant's motion to appoint counsel (ECF No. 89) is **granted**, and the Federal Public Defender, or a designee, is hereby appointed to represent Defendant with regard to his FSA Motions.

IT IS FURTHER ORDERED that Defendant, through counsel, shall file a supplemental brief within **twenty-one (21) days** of the date of this Order addressing: (1) whether Defendant is eligible for a sentence reduction under the FSA; and (2) if so, the impact of the FSA on Defendant's original sentence and the extent of any reduction authorized by the FSA. The Government shall file a supplemental response within **twenty-one (21) days** after Defendant files his supplemental brief.
