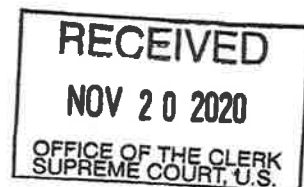

RULE 44 NOW DEMONSTRATED

Koehl has been DENIED BY THE STATE AND FEDERAL COURTS FOR TEXAS ANY AND ALL LEGAL INVESTIGATORY PROCESS TO HIS CLAIMS THAT HAVE OUTSTANDING EXCEPTIONAL MERIT, SUPPORTED BY AND THROUGH THE STATE'S CERTIFIED RECORDS IN CLEAR AND CONVINCING VISIBLE DEMONSTRATIONS OF MULTIPLE UNITED STATES, CONSTITUTIONAL RIGHTS VIOLATIONS AGAINST Koehl FOR (29) YEARS, UNDER SEVERAL STATE AND FEDERAL CAUSE NUMBERS TO NO AVAIL.
