COMES NOW PETITIONER, FRANK JOSEPH SCHWINDLER, pro se, and pursuant to 28 USC §1746, and Supreme Court Rule 39, certifies under penalty of perjury that each fact set forth within is true and accurate upon personal knowledge, and moves the Court to grant leave to proceed in this Court in forma pauperis, showing:
