WHEREFORE, the Petitioner prays that this Court grants this Motion and set an Appeal Bond in this matter.

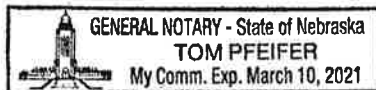

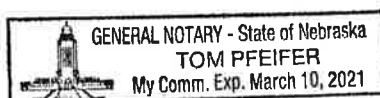
