MOTION FOR LEAVE TO PROCEED *IN FORMA PAUPERIS*


The petitioner, Daniel Frederickson, asks leave to file the accompanying petition for a writ of certiorari without prepayment of costs and to proceed in forma pauperis. Petitioner was granted leave to so proceed on his automatic appeal to the California Supreme Court, which appointed the California State Public Defender to represent petitioner on direct appeal pursuant to California Penal Code sections 1239 and 1240.

The undersigned was the Deputy State Public Defender assigned to petitioner's case. In early September 2015, the undersigned retired from the State Public Defender's Office, and subsequently filed a motion with the California Supreme Court to be appointed as counsel for petitioner on direct appeal. On September 30, 2015, the California Supreme Court relieved the State Public Defender as the attorney of record for the direct appeal and appointed the undersigned as the court-appointed attorney of record for the appeal. appointment order, dated September 30, 2015, is attached hereto. I am being paid by the California Supreme Court because petitioner has proceeded, at all times, *in forma pauperis*.

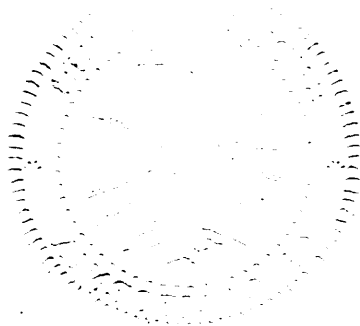
