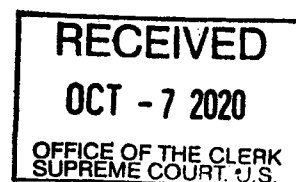
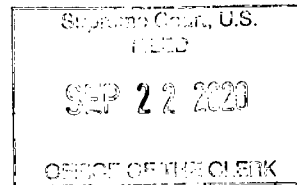

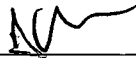
**MOTION FOR LEAVE TO PROCEED

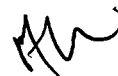
