**ORDER DISMISSING DUPLICATE FILING AND DIRECTING  
COURT CLERK TO RETURN PETITIONER'S DOCUMENTS AND  
BARRING PETITIONER FROM FILING ANY FURTHER  
REQUESTS FOR POST-CONVICTION RELIEF IN OKLAHOMA  
COUNTY DISTRICT COURT CASE NO. CF-2011-1583 AND  
ISSUING DIRECTIVE TO CLERK TO NOTIFY COURT  
ADMINISTRATOR OF FRIVOLOUS ACTION**

On June 4, 2020, Petitioner Christian, *pro se*, filed a Petition in Error attempting to appeal to this Court from an order denying his most recent application for post-conviction relief in Oklahoma County Case No. CF-2011-1583. The matter was assigned this Court's Case No. PC-2020-372. This is Christian's third attempt to challenge his conviction in the District Court of Oklahoma County utilizing the Post-Conviction Appeals process. On June 5, 2020, Christian filed a subsequent Petition in Error, attempting to appeal

the denial of his request for post-conviction relief in Oklahoma County Case No. CF-2011-1583. That matter was assigned this Court's Case No. PC-2020-377.

Christian's post-conviction filing assigned this Court's Case No. PC-2020-377 is an exact duplicate of the June 4, 2020 filing which was assigned this Court's Case No. PC-2020-372. The duplicate filing assigned Case No. PC-2020-377 is **DISMISSED**.

We now address Christian's filing assigned this Court's Case No. PC-2020-372.

On two prior occasions this Court has addressed Christian's challenges to his conviction and advised Christian that he has exhausted his remedies in this matter. *See, Christian v. State*, PC-2013-583 (October 17, 2013) and *Christian v. State*, PC-2016-425 (July 8, 2016). Petitioner's most recent filing is a direct violation of this Court's order barring him from attempting to collaterally attack his conviction in Oklahoma County Case No. CF-2011-1583.

**IT IS THE ORDER OF THIS COURT** that Petitioner has **EXHAUSTED** his State remedies regarding the issues raised in his various applications for post-conviction relief, challenging his

conviction in Oklahoma County Case No. CF-2011-1583. Subsequent application attempting to collaterally appeal Petitioner's conviction in this matter is **BARRED**, and the Clerk of this Court is directed to accept **NO FURTHER FILINGS** from Petitioner in Oklahoma County Case No. CF-2011-1583 without prepayment of filing fees. See, Rule 5.5, *Rules of the Oklahoma Court of Criminal Appeals*, Title 22, Ch.18, App. (2020). The Clerk of this Court is **DIRECTED** to return Petitioner's filings to him.

**IT IS THE FURTHER ORDER OF THIS COURT** that Petitioner is found to be a prisoner who, while incarcerated, brought this action, and that such action is frivolous, malicious, and fails to present any claim for which relief might be granted in this Court. The Clerk of this Court is directed to forward a copy of this Order to the Director of the Administrative Office of the Courts for such processing as the Director may deem appropriate in connection with the registry maintained by her under 57 O.S.2011, § 566.2.

Issuance of this order concludes these proceedings before this Court. The Clerk of this Court is directed to transmit a copy of this order to the Court Clerk of Oklahoma County; the District Court of

Oklahoma County, the Honorable Natalie Mai, District Judge;  
Petitioner and counsel of record.



**ORDER DISMISSING THIRD APPLICATION FOR POST-CONVICTION RELIEF**

This matter comes on before the undersigned Judge of the District Court for consideration of Petitioner's third Application for Post-Conviction Relief and the State's Motion to Dismiss the same. The Court, being fully advised, finds that the State's motion to dismiss should be and is hereby granted.

On October 21, 2011, Petitioner was sentenced after jury trial to concurrent terms of thirty-six (36) years imprisonment for Manslaughter in the First Degree, AFCF (2 or more), twenty-five (25) years imprisonment for Pointing a Firearm at Another, AFCF (2 or more), and twenty (20) years imprisonment for Possession of a Firearm After Felony Conviction, AFCF (2 or more). The Court of Criminal Appeals affirmed Petitioner's Judgment and Sentence on direct appeal. *Christian v. State*, No. F-2011-957 (Okla. Cr. March 22, 2013) (not for publication).

Petitioner, *pro se*, has filed two prior applications for post-conviction relief. His original Application for Post-Conviction Relief was denied by the District Court on June 6, 2013, and the Court of Criminal Appeals affirmed. *Christian v. State*, No. PC-2013-583 (Okla. Cr. October 17, 2013). The Court of Criminal Appeals further issued the following order: "IT IS THE ORDER OF THIS COURT that Petitioner has EXHAUSTED his State remedies

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that Petitioner's third Application for Post-Conviction Relief is **DISMISSED** and all other relief requested are hereby denied.
