ADDENDUM PAGE - ANSWER TO QUESTION 12

I have been incarcerated in federal custody since January 4, 2016. I have been unemployed since arrest and have had no income in that time. I have no savings, no assets, and no resources to draw significant amounts of funds from. I have a meagre inmate job that usually pays me \$0.12/hour for a total of \$8-12 per month. Unfortunately, we have not worked nor been paid since March 2020 when the COVID-19 emergency locked-down federal prison facilities nationwide and stopped all inmate movement and work details. I receive \$100-150/month from my elderly parents who are on a fixed income. This usually pays for my quarterly "inmate financial responsibility program" to pay the restitution order I am challenging in this 2255 action, limited items from the overpriced prison commissary, especially hygiene items, stationery and postage, materials I need to prepare and file my legal filings including producing photocopies of legal work (at \$0.15 per page--I'd have to work 110 hours a month at my inmate job to afford one copy of this petition for a writ of certiorari), as well as telephone and email expenses to call home to my family. I have little to no money left over for indulgences (i.e. candy) and cannot save enough funds to pay for legal filing fees. Unfortunately, surviving and taking care of your basic human needs in prison is punitively expensive and the government has no pity in taking what little I have by "diming and dollaring" me.
