
## STATEMENT OF THE CASE

I am writing to appeal an opinion made by the Supreme Court of New Jersey on March 10, 2010 in regards to denial of unemployment benefits for the period of November 1, 2015 through February 6, 2016. I was living in Northern New Jersey, Bergen County (Westwood NJ) on the night of September 25, 2015 my 34 year old son and I starting receiving death threats via email. The Westwood NJ Police Dept was contacted (see police report attached), our home was watched overnight and we were notified by the police on Saturday, September 26 that they did not have the manpower to keep watch over our home, Sunday night we decided to leave our home in the middle of the night and run for our lives. We traveled through several states and ended up in an unknown location in the state of Pennsylvania on October 1, 2015. The day we arrived in Pennsylvania we were visited by the Pennsylvania Police and was advised to refrain from using our cell phones and computer for fear of being tracked, we were also told to remain inside and not venture out. My son and I both had great jobs in New Jersey which we had to give up. We both decided to apply for unemployment benefits. My 34 year old son benefits were granted immediately thereafter and he was able to collect. I applied with the same police report as my son but my benefits was denied as my leaving my job voluntarily. I appealed to The NJ Board of Review and the decision was upheld, after the decision of the Board of Review I applied to The Appellate Court of New Jersey. The Appellate Court reversed the Board's decision stating that i did have a legimate reason for leaving my job because of

death threats. The Board of Review decided with the appellate Court but stated benefits would not be waived because i did not spend time looking for work when we arrived in Pennsylvania. We arrived in Pennsylvania and followed the advice of the police and did not go outside or use the phone or computer. January 2016 i was able to use the computer of another person and tried to find remote work to do but was not able to do so. I was really afraid to go out but all i could think about was being gunned down in the street. June 2016 we received notification that the young man who had been threatening us had previously lured two young men into a warehouse in Paterson NJ and shot and killed both of them, he had been sentenced to life without parole. I then started to venture out to look for work but circumstances beyond my control made it difficult. I am now in a place where i have never been, 69 years old, non licensed driver but i refused to give up the search, after numerous interviews i finally got a job in August 2017 doing medical billing and was employed until doctor retired December 2019. I am asking you to PLEASE review my case and perhaps you will understand why i did not look for work between 11/1/15 through 2/1/16. The only thing i could think of was staying alive. I applied for Unemployment because i thought it was the right thing to do. I got my first real job where taxes and unemployment insurance was taken at the age of 18. I worked for 50 years, never got fired and collected unemployment twice from two layoffs. We know we are living in a time where death threats can not be ignored. I feel based on the circumstances my benefits should have been granted the same as my son's benefits. I don't know what will happen after this review but I am GREATFUL at the age



of 73 i'm still HERE.

### REASONS FOR GRANTING THE PETITION

I am Praying The Supreme Court of The United States of America Will Grant my Petition.

September 25, 2015 in Bergen County N.J. I was forced to give up my home and my job because of death threats on my life and my son. We were running for our lives and ended up in an UNKNOWN location in Pennsylvania. 10/1/2015 We were visited by The Pennsylvania Police and was told to stay inside of the place, refrain from using our cell phones and computers so we could not be tracked, because of the police instructions we decided to apply for Unemployment. I filed for benefits November 2015 with a copy of the police report (attached) and my benefits were denied. Stated I did not have a valid reason for leaving my job. My 34 year old son file with the same police report as my self and his benefits was granted. December 8, 2015 I filed an Appeal with the ~~Appellate Court~~

N.J. Board of Review and the decision was upheld on May 3, 2016. I filed an Appeal with the Appellate Court 6/16/2016 they reversed the Board of Review decision and sent the claim back to the Board of Review. The Board of Review then decided that I did have a valid reason for leaving my job but my benefits would not be granted because I did not look for work when I arrived in Pennsylvania. It was impossible to look for work because we had been told by the police officer in Pennsylvania to stay in. I refiled an Appeal with the Appellate Court, they reversed their decision and agreed with the Board 10/31/19. November 14, 2019, I filed an Appeal with The N.J. Supreme Court and March 10, 2020 my petition was denied without an explanation (see attached) I contacted the Clerk of the Supreme Court to see if I could get an explanation as to why. I was told by the clerk it was the

Judge's decision and there was no reason as to why. This has really bothered me. I am now 73 years old I got my first real job where taxes was taken when I was 18 years old, Collected Unemployment Once in my 50 year work history.

June 2016 we were informed that the young man who had threaten our lives had been Sentenced to life without parole because he had lured two young men to a warehouse in Paterson N.J. and shot and killed both of them, Shortly thereafter I felt it would be OK to start looking for work. It wasn't easy because at the age of 70 it's not easy in Pennsylvania because of age discrimination.

I manage to find another Medical Billing job 8/18/17 and worked until the doctor retired 12/1/19. I don't feel I have been treated fairly because I feared for my life. I had a great job where I was an Executive Board Union member, lived in a very nice quiet peaceful town in Bergen County N.J. and I had to leave it all behind

because I was afraid of being murdered.
