MOTION FOR LEAVE TO PROCEED *IN FORMA PAUPERIS*

Petitioner, Deandre M. Smith, by attorney Dana LesMonde, respectfully moves the court to enter an order permitting him to proceed *in forma pauperis*. As grounds for, and in support of his motion, petitioner states as follows:

1. Mr. Smith is without funds to prosecute this action and has been found by the State of Wisconsin to be indigent for the purposes of all trial and appellate proceedings in this matter.

2. Pursuant to Chapter 977 of the Wisconsin Statutes, Mr. Smith has been represented and continues to be represented in this matter by counsel provided by the Office of the Wisconsin State

Public Defender. The Office of the Wisconsin State Public Defender is responsible for determining which criminal defendants are indigent and thus entitled to appointed counsel for representation of criminal defendants in the Wisconsin state courts. Wis. Stat. §§ 977.06, 977.07.

3. Mr. Smith was appointed counsel through the Office of the Wisconsin State Public Defender for representation in the Wisconsin state courts. He has also been appointed counsel through the Office of the Wisconsin State Public Defender for representation in this petition for certiorari.

4. Undersigned counsel is a private attorney who has been appointed by the Office of the Wisconsin State Public Defender to represent Mr. Smith in postconviction proceedings, including in this petition for certiorari.

5. Pursuant to United States Supreme Court Rule 39.1, Mr. Smith has not attached a declaration or affidavit in support of this motion. Instead, he has attached the Orders Appointing Counsel reflecting that he was appointed counsel in the state court below. Specifically, Mr. Smith has attached the order appointing undersigned counsel to represent him in this petition for certiorari, as well as the order appointing undersigned counsel to represent him in the Supreme Court of Wisconsin.

WHEREFORE, for all the reasons herein, petitioner respectfully requests that he be permitted to proceed *in forma pauperis* in this action.
