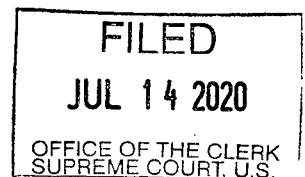

STATEMENT OF THE CASE

On October 13th 2017 a Jury Convicted William Scott Davis Jr. of one count of Cyberstalking in Violation of 18 U.S.C § 2261A (2)(B), and three Counts of Sending threatening Interstate Communication, in Violation of 18 U.S.C § 875(c). The district Court Sentenced him to a 144-month term of Imprisonment and three years of Supervised release. That Violated the protection of the First Amendment, Freedoms of Speech, Right to Petition Government For redress of Grievances, and DAVISES FAMILIAL Right of Privacy and Confidentiality. Deprived DAVIS of Right to maintain one's Innocence, Right to Self Representation, Right to impartial tribune, Right to Conflict Free trial and Appellant Counsel.

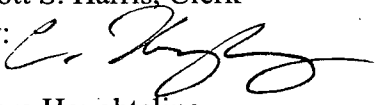
