ORDER re: Motion to proceed on the instant appeal in forma pauperis. IT IS ORDERED that the motion for leave to proceed on appeal in forma pauperis is DENIED. The appellant has not made a potentially meritorious argument that the district court erred in dismissing his complaint for failure to comply with Federal Rule of Civil Procedure 8. Mohammed's complaint is more than 500 pages long, and asserts dozens of claims that appear to be either frivolous or levied against defendants who are immune from suit. This court has previously warned Mohammed that if he continues to engage in abusive litigation practices, he will be subject to sanctions. See Mohammed v. Alonso, 20-2310 (7th Cir. Oct. 2, 2020). Because Mohammed filed this appeal and motion before the warning the court will not impose sanctions at this time, but it is highly likely that a filing such as this in the future would result in sanctions. IT IS FURTHER ORDERED that appellant shall pay the required docketing fee within 14 days, or else this appeal will be dismissed for failure to prosecute pursuant to Circuit Rule 3(b).
