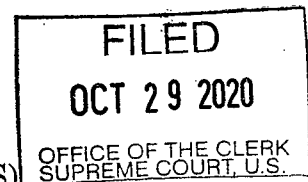

**ORDER REMOVING PRO BONO COUNSEL, CONDITIONALLY  
APPOINTING SUBSTITUTE COUNSEL, AND STAYING CASE**

In its opinion remanding this case [Doc. #101], the Sixth Circuit, noting certain issues regarding Mr. Campbell's former *pro bono* counsel, suggested that "circumstances may still exist that would warrant the appointment of substitute counsel to assist Campbell with filing a response to the defendants' renewed motion for summary judgment." I find that such circumstance do exist.

Therefore, attorney Rondald D. Diebel is removed as *pro bono* counsel, and shall have no further obligations in this case, except for providing substitute counsel with his file.<sup>1</sup>

The Court will attempt to procure substitute *pro bono* counsel for Plaintiff. This case

<sup>1</sup> Mr. Diebel previously filed a motion to withdraw on July 16, 2013 [Doc. #84], which the Court denied [Doc. #85]. Based on subsequent events, including the Sixth Circuit's opinion, it is appropriate to revisit Mr. Diebel's request.
