## **MOTION TO PROCEED IN FORMA PAUPERIS**

Petitioner Sherman Johnson, Jr. hereby moves this Court for an order for leave to proceed in forma pauperis with the Petition for Writ of Certiorari and related matters before this Court.

The United States Court of Appeals for the Eighth Circuit previously appointed undersigned counsel on September 7, 2018 after finding Petitioner was indigent and could proceed in forma pauperis with his appeal before the Court of Appeals.
