- 3. The order of the United States District Court finding Petitioner to be indigent and appointing undersigned counsel is attached hereto, pursuant to Supreme Court Rule 39.1.

WHEREFORE, Petitioner respectfully requests that this Court grant his motion and allow Petitioner to proceed *in forma pauperis* and without prepayment of costs.

ORDER
