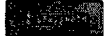

PER CURIAM

Defendant Donna Raively agreed to arbitrate a dispute over
the fee that her attorney, plaintiff Thomas A. Whelihan, sought
for legal services rendered. After a hearing, see R. 1:20A-3(b),
the District Fee Arbitration Committee entered an award for the

full amount Whelihan sought, \$13,557.60. The Disciplinary Review Board affirmed the award, by dismissing her appeal. See R. 1:20A-3(c). In a subsequent summary action to enforce the award, see R. 1:20A-3(e), Whelihan obtained a judgment in that amount, plus \$75 costs, and interest. Raively appeals from that June 27, 2017 order of judgment, raising various contract defenses to her attorney's fee claim.

We are constrained to dismiss for lack of jurisdiction. "In any application for the entry of a judgment in accordance with [the fee arbitration] rule, no court shall have jurisdiction to review a fee arbitration committee determination." R. 1:20A-3(e); see also In re LiVolsi, 85 N.J. 576, 601-02 (1981) (stating that the purpose of limiting appellate rights from fee arbitration decisions is to control the time and expenses incurred by clients in resolving fee disputes); Linker v. The Company Car Corp., 281 N.J. Super. 579, 586 (App. Div. 1995) (finding that Law Division judge was powerless to review a fee arbitration award). Had plaintiff wanted to retain her full appellate rights, she should have allowed the fee dispute to proceed to court in the usual course. Instead, she surrendered those appellate rights when she opted for binding fee arbitration. See R. 1:20A-2(a) ("A fee arbitration determination is final and binding upon the parties except as provided by R. 1:20A-3(c).").

Appeal dismissed.





EXPLANATION OF INTEREST CALCULATION

The principal amount is \$13,952.25.

The annual interest rate, pursuant to Rule 4:42-11(ii), rate is 0.50% per year, or in decimal form, $0.50/100=0.005$.

The time since the judgment was docketed is six (6) months.

Since the interest rate is "per year", and the time interval is six (6) months, the amount of time, six (6) months was divided by twelve (12), to arrive at 0.5 year time period.

To find the simple interest, we multiplied $\$13,952.2 \times 0.005 \times 0.5$ to get \$34.88 in interest due.

Dear Your Honorable Stuart Rabner,

I am asking for a motion to reconsider my case against Mr. Thomas Whelihan. I did not pay off the judgement willingly, but out of necessity.

The roof over my grandchildren's head was being threatened and I did what any grandmother would do. I went out and got a loan against another property of ours. I did not pay the whole amount because I agreed with it. I felt forced to do so, because the Sheriff came out to price our home and everyone's belongings and was going to put the property up for sale. This caused a lot of emotional stress among our family.

I feel Mr. Whelihan deserves some compensation for his work. I dispute the some of the \$13,952.25 though and have tried several times to come to an agreement with him.

Mr. Whelihan was originally consulted about our Estate and Will because I have a child with special needs and certain things needed to be dealt with. In the meantime, my father passed away and I needed help on my father's estate case. I have always remained in good credit status with all debts I have owed. I believe when Mr. Whelihan was looking into our Estate to construct a will, he saw what our assets were and thought we would have the money to pay him. The properties at this time are owed more than they are worth.

We expected monthly billing, and never received a bill until almost a year after the case was started and contract signed. I had asked Mr. Whelihan several times what I owed, he would tell me don't worry about it. When you sell the house (my father's house) you can pay me back is what I was told. At that time, I did put the estate house for sale, but it never sold. Had I received a bill every month, I would've questioned why it was so high and disputed it before we reached where we are now. I don't understand why Mr. Whelihan would work all that time on my case without a retainer and bill me that amount all at


once without any other money being exchanged. Mr. Whelihan has failed to answer why he breached his contract and violated an ethical rule himself by not billing me every month as per contract.

Mr. Whelihan didn't represent me to his fullest potential. My father had a bank account with my sister's name on it. Mr. Whelihan told me I was entitled to that money. When I consulted another attorney months later, he said I had no right to the money. Mr. Whelihan should have known at that time that the case was done and there was nothing left to pursue. He continued to bill me for unnecessary hours.

I feel as though the decision should have gone in my favor because Mr. Whelihan never answered to the petition for certification back in April. He had a limited amount of time to respond and never did.

If this decision were to go in my favor, would you please enter a judgement so I can reobtain the money I paid out.

Donna Raively v. Thomas Whelihan : Brief explaining facts which I will prove for grounds for an appeal :
File No : IIIB-2016-0005F.

The Fee Committee failed substantially to comply with the procedural requirements governing Fee Arbitration matters, resulted in unfairness and unjust result.

I am requesting the award from Arbitration settlement and file for a trial, I would need you to send any form that I need for any settlement awards, and forms to stop liens that may apply to me.

I was laughed at, and was not giving time to present any cross examine to Mr. Whelihan, I was told the committee has all my letters to Mr. Whelihan and they will review them, I am on security disability, if any money is due by me, I am also requesting monthly payments and no liens, since I am married and are assessed together, my husband is not part of the estate matter.

1. Mr. Whelihan records did not show his fee's and billing monthly like he stated, he did not send fee statement every 90 days only three during two years.

2. My open argument started with the committee, was in the State Of New Jersey the law requires a will to be heard, Mr. Whelihan was hired in a timely matter for him to contest the will, committee states there was time limitations in contesting the will, when Mr. Whelihan put in a motion for me to be the executor he then withdrew his motion why? he so called then and told me your sister took the money.

On August 27, 2014, before my father passed off, Mr. Whelihan was at my house planning a ESTATE PLANNING, I also questioned my sister and I told him, that both of us were on my father's IRA account, on 11/8/2014 my father passed away, Mr. Whelihan received a call and was asked to handle my father's estate in court, because I felt my sister was doing wrong by me, I do have my estate planning letter dated August 27, 2014, Mr. Whelihan told the committee that he didn't charge use for this, this was something we were still looking into then my father passed away.

I then wanted the guardianship of my sister case removed from the estate case, my sister was not on the will. Mr. Whelihan was questioned time from time, doing the cases, because both lawyers were using the case to fight with, (see letters) he just ignored me, I stated this to the committee on the will part I was laughed at by Mrs. Davis and was told this is not true, with her addressing a comment to the committee the other members did not comment. (SUDDEN ANGER RUSH) by Mrs. Davis started through the hearing).

3. I explained if Mr. Whelihan had filed a motion to the courts on the reading of the will, he then knew nothing could be done I was not the executor of my father's estate, towards the end of the case, it was only then I went to another lawyer, to get another opinion (see Attorney Hoffman's letter) this is when Mr. Whelihan removed himself from the case, I felt he needed to end the cases with the other lawyer, no other lawyer would handle this, at the end of settlement.

4. Mr. Whelihan made a palpable lie, we did have a meeting agreement with me, if the estate house sells he would be paid, if this was not the case then why didn't Mr. Whelihan file for the fee's to be informed, he stated to me he would wait for the house to sell, during the case, the house was up for sale but did not sell, his

On 3/16/17 the review board committee, Bonnie Gorman, Patricia Davis, Bert Afonso, Mr. Whelihan, has my sworn statements in writing, that the committee was to review before a determination dating 3/29/17.

During the hearing my time was very short and was not given time or even asked to cross-examine Mr Whelihan, because of other cases that needed to be heard that day, the committee told me they would review all letters, and other information on the case, copy' you do have.

The committee also was sent a letter explaining a notice of a appeal form, for arbitration committee determination sent out on 4/19/17(see copy).

On 4/28/17 I received a letter from Ms. Davis, that my appeal for arbitration determination was received in a timely matter, with this appeal, I want the Attorney General to review the case or a Judge to hear my case.

On 5/3/17 I was sent a copy from Ms. Davis, from disciplinary review board, Louis Guarino I don't recall him on the hearing panel list or remember his name , but I will address his letter, I reject his letter, and dispute his comments.

1. Mr. Guarino states I was monologued, and so was my husband, you would be too since, we were laughed at and was told they had other cases to hear, they were inappropriate remarks about the will. The committee was repetitious towards us.
