
ORDER


On December 30, 2019, the parties were allowed to serve and file letter briefs within 15 days regarding whether the appeal should be dismissed. No briefs pertaining to this issue were filed. We conclude the appeal must be dismissed.


The October 29, 2019, notice of appeal stated appellant is appealing "Court Order on 10/01/2019 The Court Enters A Not Guilty Plea on Behalf of the Defendant despite Motion to Appear Pro Se in the Docket and Ordering a Faretta Waiver despite Defendants [*sic*] Motion to Appear Pro Se." (Capitalization in original.) In an application to stay filed with this court, appellant appears to maintain he seeks to appeal the trial court's orders denying his request that counsel be appointed to represent him and entering a plea of not guilty on his behalf. But, the appeal from these orders is not taken from a final order of conviction or an order made after judgment affecting appellant's substantial rights. (Pen. Code, § 1466, subd. (b).) Accordingly, the October 29, 2019, appeal is dismissed.


