**PARTIES' RULE 46.1 AGREEMENT TO DISMISS PETITIONER ROMELL
BROOM'S PETITION FOR A WRIT OF CERTIORARI**

Petitioner Broom died on December 28, 2020. Pursuant to Supreme Court Rule 46.1, the parties agree to the dismissal of Mr. Broom's pending Petition for a Writ of Certiorari.

Petitioner Broom was an indigent death row prisoner. His attorneys, by orders dated January 15, 1999, were appointed by the United States District Court for the Northern District of Ohio, under the Criminal Justice Act, 18 U.S.C. §3006A, to represent Petitioner in all of his habeas corpus proceedings. Counsels' appointments were continued by order of the United States Court of Appeals for the Sixth Circuit on June 10, 2019. Petitioner Broom's Motion to Proceed In Forma Pauperis is pending before this Court. The parties anticipate that the dismissal will recognize the deceased Petitioner's indigent and IFP status and will waive any costs.
