

ORDER

THE BACKGROUND OF THIS ORDER IS AS FOLLOWS:

Defendant, Willie Tyler, has filed a pro se motion, styled as a "memorandum of law," under the All Writs Act and Fed. R. Civ. P. 60(b). In the motion, he argues that his convictions under 18 U.S.C. §§ 1512(a) and 1512(b) are invalid under *Arthur Andersen LLP v. United States*, 544 U.S. 696, 125 S.Ct. 2129, 161 L.Ed.2d 1008 (2005). Essentially, Defendant argues that in light of *Arthur Andersen*, he was convicted for conduct that was not criminal under the statutory sections.

A review of the motion indicated that we may have jurisdiction of it under 28 U.S.C. § 2241 because it presents a claim that could not have been presented in Defendant's earlier 28 U.S.C. § 2255 motion and one that asserts his innocence of the crimes. See *In re Dorsainvil*, 119 F.3d 245 (3d Cir. 1997). We therefore required a response from the Government. Having reviewed that response, we believe Defendant could benefit from representation of counsel on the motion.

Accordingly, this 12th day of August, 2010, it is ordered that:

1. Pursuant to 18 U.S.C. § 3006A(2)(B), the Federal Public Defender is appointed to represent Defendant on proceedings involving his pro se motion (doc. 310), styled as a "memorandum of law," under the All Writs Act and Fed. R. Civ. P. 60(b).
2. The Federal Public Defender shall have sixty (60) days from the date of this order to file a brief in support of the motion.
3. Further briefing shall await review of any brief the public defender may file.
