

ORDER

The Eighth Circuit assessed the full \$505 appellate filing and docketing fees against James Davis, remanding collection of those fees. Doc. No. 56. Based on information contained in his application for leave to appeal *in forma pauperis* [Doc. No. 54], no initial partial filing fee is assessed. Davis's custodian shall withdraw and forward to the clerk monthly payments in the amount of twenty percent of the preceding month's income credited to his inmate account each time the amount in the account exceeds \$10 until the \$505 fee has been paid in full. 28 U.S.C. § 1915(b)(2). The payments shall be clearly identified by the name and number assigned to this case. The clerk is directed to send a copy of this order to: (1) the Warden of the Grimes Unit, 300 Corrections Drive, Newport, Arkansas 72112; (2) the ADC Trust Fund Centralized Banking Office, P.O. Box 8908, Pine Bluff, Arkansas 71611; and (3) the ADC Compliance Office, P.O. Box 20550, Pine Bluff, Arkansas 71612.
