MOTION FOR LEAVE TO PROCEED *IN FORMA PAUPERIS*

Petitioner Dantazias Raines, by and through undersigned counsel and pursuant to Supreme Court Rule 39, respectfully requests leave to proceed *in forma pauperis*. Mr. Raines is filing a petition for writ of certiorari simultaneously with this Motion, seeking review of the decision of the Supreme Court of Georgia affirming the denial of Mr. Raines's request for a jury to determine whether he is eligible to be sentenced to life without parole for a crime committed as a juvenile.
