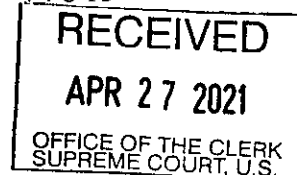

## WHY PETITION FOR REHEARING MUST BE GRANTED

On March 22, 2021, this Court denied the petition for a writ of certiorari filed by Petitioner Christopher Torres, also known as Christopher Muhammad (hereinafter "Muhammad"). Muhammad respectfully declares that this petition for rehearing must be granted for the following "intervening circumstance(s), of a controlling effect," and/or "extraordinary circumstance(s)," and/or "independent reason(s)":

Muhammad has, in the past, informed this Court that he is [a] [r]epresentative of the [O]ne known—among many other Names—as "God," "Messiah," "Mahdi," and "the Sovereign of the Universe."<sup>\*1</sup> Muhammad also has informed this Court that God visited this country in the early 1900's in the Person (the Human body) of Master W. Fard Muhammad (hereinafter "God"), Who is in the Heavens in a giant aircraft (referred to as the "Motherplane"),<sup>\*2</sup> which former military and political officials from this country and elsewhere have testified that they have tried to chase and attack "without success."<sup>\*3</sup>

While Muhammad is [a] [r]epresentative of the Most High God, [the] [R]epresentative of said God is Louis Farrakhan who on July 4th, 2020, delivered a message to the world at www.noi.org titled, "The Criterion". During the said July 4th, 2020 message, Farrakhan said the following in regards to the deadly COVID-19 which currently has variants resistant to vaccines:

- "...The deadly corona-virus is a God-sent pestilence and neither America, China nor others will escape its grip. ..."
- "...I want to tell you right up front you will not conquer this virus because it didn't come from Wuhan. It didn't come from Fort Detrick in Maryland because if you had made it, you would know how to handle what you made. But you don't know this virus, it's new it's different. It mutates and goes in different directions with a different strain of itself. ..."
- "...We are under the Judgement of God. ..."
- "...We all will reap what we sow. ..."
- "...America won't solve it (COVID-19). The scientists of the world won't solve it. ..."
- "...What will you do with corona, a pestilence from God? What will you do? What can you do? You are at your wits end. ..."

In March 2020, a high ranking Texas prison official, named Akbar Shabazz, wronged Muhammad. Immediately after Shabazz wronged Muhammad, God told Muhammad to forgive Shabazz pursuant to HOLY OUR'AN 45:14 (Maulana Muhammad Ali translation, p. 948 (1999)), and Muhammad obeyed God. In April 2020, God killed Shabazz with COVID-19.

Muhammad is just like God Who says in EZEKIEL 33:11—"...As surely as I live, declares the Sovereign Lord, I take no pleasure in the death of the wicked, but rather that they turn from their ways and live. Turn! Turn from your evil ways! Why will you die...?"

If this Court does not grant this petition for rehearing so Muhammad will receive justice in this instant case, God has already told Muhammad to forgive everyone at this Court and He (God) will reward all of you (who are handling this petition) with what all of you earn and He (God) will not wrong you.

#### CONCLUSION

Due to the above said intervening circumstance(s) of a controlling effect, and/or extraordinary circumstance(s), and/or independent reason(s), this petition for rehearing must be granted.
