

The originating civil case below is from a restaurant lease which I and my brother guaranteed. The Lessor, with RICO activity, concealed the material facts of impending road construction and conveyance of frontage to GDOT. In seeking to make the restaurant survive 4 years of road construction, I emptied my retirement fund, savings, etc. to cover debts incurred by the restaurant and am still paying off those debts. Through fraud upon the court, a judgment of \$394,617.47 was issued against me and my brother payable to the Lessor, an entity of a billion-dollar corporation. I have spent more than \$5,000 in court fees fighting collateral issues created by court officers, including their removal of my documents from the court record.
