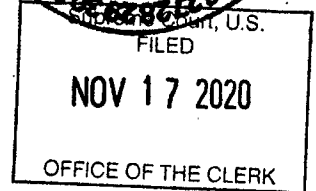
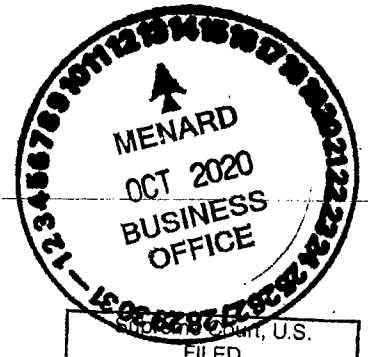

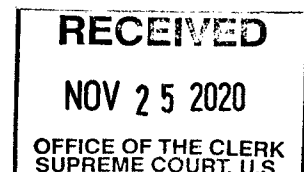

**AFFIDAVIT OR DECLARATION
