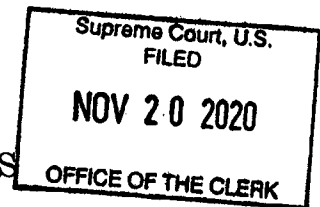



**AFFIDAVIT OR DECLARATION



