

## STATEMENT OF THE CASE

U.S. District Judge Lashawn Darcy Hall Dismissal of my complaint fall under the 18 U.S. code 2382 Misprision of treason. Because there's nothing frivolous about being a prisoner in your own home and community being sort after and hunted simply because you do not share in the same Religious beliefs or because you are different and need a little more help than others, and the reporting of a hate crime deserves to be recognized, and heard Honorable Ch. of Justice John C. and I was told by the prose clerk office (3) that no decision had been made yet. time went by and I forgot to check back right away because I was tired and in great pain from lack of sleep on very strong medication (which is a direct result of the defendants actions attacking in the building lobby of 1070 E.N.Y Ave in 2013. by these two Devil-Gang members) causing me nerve injury). constantly being pursued by one or more groups of these defendants hungry, mentally and physically exhausted homeless as of 10-12-2018 from being forced out of my apartment at 1677 St. Johns Pl. my safety net gone (if it ever was one at all your Honor to my knowledge it was a set-up from the very start and I can prove that it was just what I stated) fully exposed even more so to the prior dangers I was running and trying to hide which is impossible to do when your oppressors have access to D.H.S.
