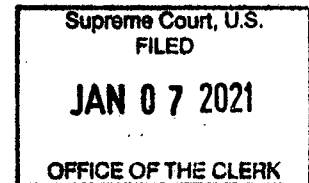

The Petitioner ask leave to file hrs Extra Ordinary / Habeas Corpus without payment of cost and to proceed in forma pauperis.

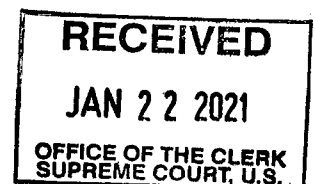
