He (Lt. Monday) stated all this legal mail was not able to be authorized through the Legal Mail procedure, (due to wrong authorization Code / number and / or no authorization Code / number was on the envelope / envelopes to verify authorization from the Court's), through the Legal Mail procedure here at SCT-Rockview.

Lt. Monday, did give me a Copy of the Confiscated items Receipt, (which I am Sending to this Honorable Supreme Court of the United

States as evidence with this letter). Lt. Monday, told me to hold on to the Confiscated item receipt until (Monday) the 3rd day of May 2021 and Someone from Security will be contacting you and you will be getting your legal mail no matter what, (100% garenteed), I was going to be called down to the Security Office in the (DW Building) and someone from first shift Security will be opening it in front of me and I will be recieving my legal mail.

On monday mourning the 3rd day of May 2021 I went to the prison block office were I am housed on and asked (Sgt. Curtis) to Call the Security office and see if I could go/ come down and recieve

my legal mail that (Lt. Monday) Confiscated from me on (Friday) the 30th day of April 2021 due to not being able to authorize the envelope / legal mail.

Sgt. Curtis, told me to go to my cell and get him the Confiscated item receipt and give it to him and he will call them so I could go down and get my legal mail. He called the Security Office and someone from there, (which he did not say who), said they mailing it back to the sender, which would / is this Honorable Supreme Court of the United States.

The very next day, on the 4th day of May 2021 I went again to the block office on CA Block where I am housed at SCI-

First Shift Security Lt. Wooster, stated the legal mail was returned to the sender and was going to start telling me the reason, (which I already knew), why this happen. I stopped (Lt. Wooster) immediately when he began to speak to me, and asked him where is my paperwork / evidence to this very serious issue with my legal mail even happening.

Lt. Wooster, told me that's not how we do

things around here, and before he continued to keep on speaking, (I stop him) and told Lt.
