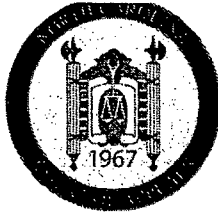

ORDER


DEFENDANT

THIS CAUSE coming on to be heard by the undersigned Judge Presiding in the Durham County Superior Court pursuant to a Petitioner's Writ of Habeas Corpus that was filed by the defendant, *Pro Se*, in the office of the Durham County Clerk of Superior Court on August 3, 2020. The Court finds that the Defendant was found guilty of Felony Elude Arrest MV2 AGRVTG FCTRS in 14 CRS 218077, Misdemeanor Resisting Public Officer in 14 CRS 218078 and Obtaining a Habitual Felon Status in 15 CRS 16011; and sentence to 90 months minimum to 120 months maximum to be served in the North Carolina Department of Adult Corrections, on or about April 14, 2016 in Mecklenburg County Superior Court, Criminal Session before the Honorable Hugh Lewis.

WHEREFORE, The Courts finds that the Defendant is held pursuant to lawful process and THEREFORE the Petitioner's Writ of Habeas Corpus is denied.

The Court further Orders that the Superior Court Judicial Assistant shall mail a copy of this Order to Mecklenburg County Clerk Office and to the Defendant in the NCDAC.
