Dear Mr. Harris:

I am counsel of record for petitioner in the above-captioned case. Pursuant to this Court's Rule 12.6, I am writing to notify the Court of petitioner's belief that respondents Stephen A. Groome and Buena Vista Sanitation District which were defendants in the trial court and appellees in Tenth Circuit have no interest in the outcome of the petition for a writ of certiorari.

The trial court dismissed the petitioner's claim against Judge Stephen A Groome because it found he was entitled to immunity. The trial court dismissed the petitioner's claim against the Buena Vista Sanitation District on the grounds there was no conspiracy as defined in Section 1985(2) of the Civil Rights Act. The Tenth Circuit reversed the trial court's ruling as applied to Judge Stephen A. Groome on the grounds that the dismissal should have been a dismissal without prejudice for lack of jurisdiction based on the Rooker Feldman Doctrine despite the trial court's failure to follow that doctrine after argument by the parties. The Tenth Circuit affirmed the trial court's dismissal of the Buena Vista Sanitation District.
