CONSTITUTIONAL AND STATUTORY PROVISIONS INVOLVED

STATEMENT OF THE CASE

Two separate law enforcement agencies committed both perjury and excessive force on two separate incidents.

I was indicted (illegally) for the VofAPD incident on Aug. 12th 2012 for 2 counts of assault and was because of the audio/video of the incident.

Both the 9th Circuit and District of Arizona Courts failed to watch that evidence and said nothing about all those individuals associated with the stop and indictment.

In 2013 Tucson Police Department officers tazed me in handcuffs and a mask and when I tried to get the tapes from TPD they said they didn't exist. When I tried to get Federal Judge Kimmins to force TPD to produce the tapes she said they didn't have to.

All the Judges from the 9th Circuit failed to recognize either of those claims and are still ignoring me.

REASONS FOR GRANTING THE PETITION

Both of the lower courts failed to watch the audio/video evidence or read my words.

I don't expect you people to help because ~~all~~ all the other Federal authorities have screwed me so far.

I was indicted in 2014 for 2 Counts of Assault ~~and~~ on UofAPD Officers ~~was~~ illegally by a Grand Jury (I think you won't read that transcript and agree I was illegally indicted and put those people in prison) but won because of audio/video from that Aug 12th 2012 incident. ~~Then~~ Then for years the District of Arizona Court ~~ignored~~ me ~~seriously~~ claiming I failed to state a claim.

Read the docket's for 18:15759 and 4:20 cv 00338 and put all those people in prison.

There are a number of legal points that the Federal District Judge failed to respond to in my Motion as a Matter of Law in 4:20 - cv - 00338 that ought ~~not~~ not be ignored any further.

I expect you people to read both of those dockets and realize none of the Federal Judges read my writing or they would have simply watched the tapes so please put those Judges in prison.
