

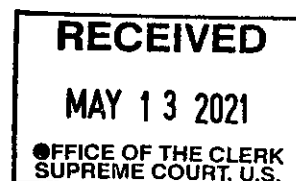

It is clear that this was the first time on April 18, 2017, Mount Sinai Beth Israel was informed that Petitioner's medical records was destroyed in a fire; because Petitioner's medical records was NOT destroy on January 31, 2015. It was destroyed on April 18, 2017, the date Mount Sinai Beth Israel (Sabrina Perry, supervisor) knowingly Petitioner was NOT destroy and, therefore, requested it on said date of April 18, 2017.

Therefore, Respondent lied and cover up FBI crimes against Petitioner.
