ORDER APPOINTING PUBLIC DEFENDER AND GRANTING FORMA PAUPERIS	

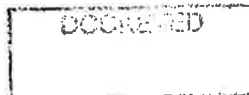
THIS MATTER coming on to be heard, and the Court being duly advised in the premises,
