DECLARATION OF TIMELY FILING PURSUANT TO RULE 29.2

CAPITAL CASE

I, Sarah Brandon, a member of the Bar of this Court and counsel of record for Petitioner Eric Williams, hereby certify, pursuant to Rule 29.2, that on February 16, 2021, I timely filed Mr. Williams’s petition for a writ of certiorari, appendix, motion to proceed in forma pauperis, and proof of service with this Court through delivery to a third-party commercial mail carrier, Federal Express (“FedEx”), for delivery on February 16, 2021.

Pursuant to this Court’s March 19, 2020 Order extending the deadline to file a petition for writ of certiorari to 150 days from the date of a lower court’s judgment,

Mr. Williams's petition due date fell on February 13, 2021, which was a Saturday. Monday, February 15, 2021, was a federal holiday. Thus, pursuant to Rule 30.1, Mr. Williams petition became due to be filed on February 16, 2021.

The State of Texas is presently undergoing an unprecedented winter storm, causing massive power outages and record-low temperatures and snow fall, and is under a declaration of disaster. FedEx has advised undersigned counsel that, due to the inclement weather in Austin, they do not expect deliveries to go out until February 17, 2021, however, notwithstanding the ongoing weather emergency, delivery will be made within three calendar days.

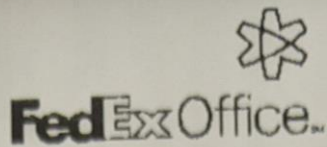
