
Before the Court is Defendant's Motion to Appoint Counsel under the Criminal Justice Act. ECF No. 173. The Motion seeks an order appointing Brett D. Kelley under the Criminal Justice Act to represent Defendant for the filing of the Notice of Appeal and any subsequent representation necessary to perfect his appeal, with the anticipation that Mr. Kelley will then be appointed to represent Defendant on appeal. The Motion further requests relieving Daniel M. Scott as appointed counsel for Defendant.

The Court has determined that Defendant in the above matter continues to be financially unable to employ counsel and finds that it is in the interests of justice that previously appointed counsel be substituted.

IT IS HEREBY ORDERED that Daniel M. Scott, Attorney ID 98395, is relieved of representing Defendant as appointed counsel.

IT IS FURTHER ORDERED that Brett D. Kelley, Attorney ID 397526, is appointed as counsel to represent Defendant pursuant to 18 U.S.C. § 3006A.
