


MANDATORY NOTICE OF CLAIMANTS RIGHT TO COURT WITHOUT "FEES"

As found in: The People of the State of New York ex rel. The Bank of Commerce Plaintiffs in Err v. Commissioner of Taxes and Assessments for City and County of New York, (2 Black 620; 17 LED 451; March 10, 1863)

Please take mandatory notice (Federal Rules of Evidence 201(d), P.L. 93-595 §1, 88 Stat. 1930, January 2, 1975) that Plaintiff has a lawful right to proceed without cost, based upon the following law:

The U.S. Supreme Court has ruled that a natural individual entitled to relief is entitled to free access to its judicial tribunals and public offices in every State of the Union. (Crandell v. Nevada, 6 Wall 35; 18 LED 745,748-749; March 16, 1868).

And as stated by the United States Department of Treasury 1789, the presenter shall not be charged fees, or costs for the lawful and Constitutionally secured right to petition for redress in matters in which he is entitled to relief, as it appears that the filing fee rule was originally implemented for fictions and subjects of the State and cannot not be applied to the presenter as he is not a collective entity, that he is a sentient self-aware, competent, responsible, adult who is a natural living man and entitled to relief (Hale v. Henkel, 201 U.S. 43; 50 LED 652; 26 S Ct. 370; March 12, 1906), and under international laws as well as the law of humanity.
