QUESTION(S) PRESENTED

- 01.) Show cause that in light of the facts presented by Congressman of Ohio James Traficant to the joint session of congress on March 17, 1993, as recorded in Congressional Record Volume 33, page H-1303, that "THE UNITED STATES" can ever claim any Constitutionally viable Cause Of Action to bring charges against we the people?
- 02.) Show cause that "THE UNITED STATES" can ever have Constitutionally sufficient Standing to bring charges against the Alleged DEFENDANT, who has never broken the Substance of the Law, has caused no Actual Harm, nor any Injury In Fact, did not hurt anybody, damage any property, or trespass upon anybody's right(s), exclusively holds a Personal Stake, is ultimately the only Damaged Party, and is the sole potential Real Party Of Interest in this case?

- 04.) Show cause that by "THE UNITED STATES" acting as the PLAINTIFF who having payed, the Judge(s), the Prosecutor(s), the Clerk(s), the Grand Jury, the Petit Jury, and the Public Defender(s) involved in the case(s) against the alleged DEFENDANT, that a conflict of interest does not exist?
- 05.) Show cause that for Judge(s) to receive the incentive of an increase to their pension for each and every one of we the people whom they convict and / or incarcerate, that a conflict of interest does not exist?
- 06.) Show cause that for any Judge(s) or UNITED STATES Attorney(s) to prosecute a crime committed outside of federally owned property, which includes only within The District of Columbia, Puerto Rico, or the territories and properties owned by "THE UNITED STATES" does not violate their Oath(s) of Office, being that "no citizen shall be imprisoned or detained by "THE UNITED STATES" except pursuant to an Act Of Congress where it is locally applicable"?
- 07.) Show cause that whereas none of THE UNITED STATES CODE and no STATUTE include any Enacting Clause or Resolving Clause, and have never been passed into positive law, that any of THE UNITED STATES CODE or any STATUTE can apply to we the people?
- 08.) Show cause that though never having amended the Constitution as prescribed in Article 5, that "THE UNITED STATES" can ever gain any power to redefine the constitutional definition of the word crime to mean, anything, other than "violation of the law of nations, counterfeiting, piracy, or treason", without also violating the 9th amendment, the 10th amendment, and several other provisions of the Constitution?
