

Since you have requested an investigation by the Judicial Conduct Board you should know what the Pennsylvania Judicial Conduct Board can do, and, more importantly, what the Board cannot do in connection with your request. The Board can take no action to protect or promote your personal legal concerns. You should not delay in seeking legal advice or taking any action needed to protect your interests.

The authority and the jurisdiction of the Board are limited to issues of whether a judge has committed misconduct as defined by the Pennsylvania Constitution, the Code of Judicial Conduct or the Rules Governing the Standards of Conduct for Magisterial District Judges. Where misconduct is found, discipline may be imposed upon a judge. If our investigation does not reveal evidence of judicial misconduct, your complaint will be dismissed.

Often, a person filing a complaint against a judge seeks advice about the case or requests help in getting a judge removed from the case, or to take certain actions. However, the efforts of the Board must be directed toward promoting institutional values for the benefit of the public as a whole, and not toward obtaining relief for or rendering assistance to any individual complainant.


