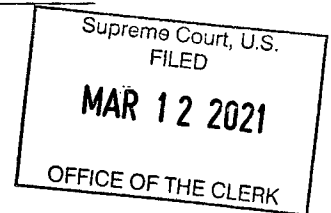



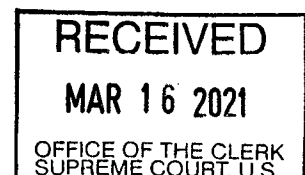
MOTION FOR LEAVE TO PROCEED IN *FORMA PAUPERIS*
