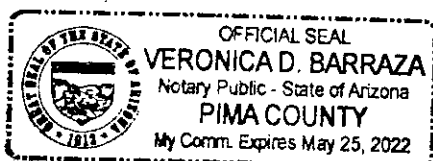

Petitioner has been incarcerated for twenty years, solely surviving on charity and gifts: Prison "jobs" are infrequent, unpredictable, and only pay .10 - .35 cents per hour, for 20-30 hours per week; if you're one of the 10% of a yard's population to have a "job". Petitioner is also under extreme duress and dealing with traumatic stress disorder, chronic anxiety, depression and insomnia while trying to litigate his case against a government with vast resources.
