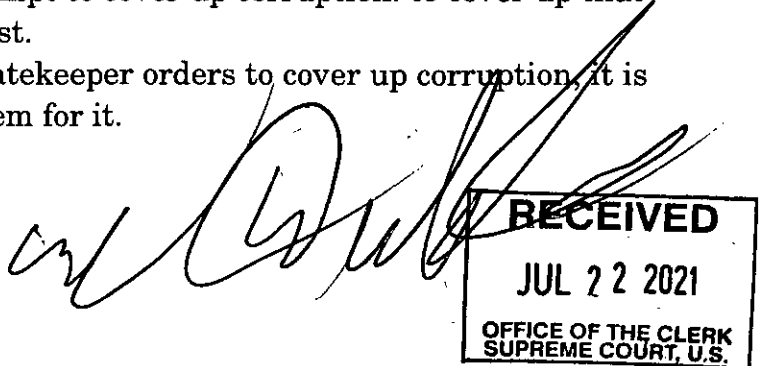

Three things I don't recall bringing up in the first petition but that are of national significance.


- 1- A government official using their power to deny a citizen of the united states their right to trial by jury. Oxley didn't care, and claimed to file a document revoking my mom's decision, There is a document when she stated it. Yet later on, Oxley filed for a court hearing to have the renunciation of the estate heard in court. Then later still, she dismissed her motion to revoke my moms renunciation. How can you dismiss something that allegedly has already been done by someone???
- 3- When Oxley represented my mother in court during the first lawsuit (Womack VS Steve Owens, John Carroll Et. Al. and Adena Widener et. Al. she did not reveal that she worked for John Carroll at Social Services, which is a conflict of interest. Oxley was appointed my Mom's Guardian Ad Litem. Oxley motioned for the case to be dismissed. Again, Oxley was not named in that lawsuit in any manner. As part of her gatekeeper order, she included that case. I believe this is an attempt to cover up corruption. to cover up that she was under a conflict of interest.

When government officials use gatekeeper orders to cover up corruption, it is time to make laws to penalize them for it.




