Dear Mr. Harris,

I am a member of the Bar of this Court and one of the lawyers for Wells Fargo Bank, N.A. (“Wells Fargo”) in the above-captioned matter. Petitioner John Nypl filed a petition for a writ of certiorari in this matter on November 30, 2020, and the case was placed on the Court’s docket on December 4, 2020. Wells Fargo was the only appellee below, and is a respondent in this matter before the Court.<sup>1</sup> Because the case clearly does not warrant review, Wells Fargo waives the right to file a brief in opposition unless one is requested by the Court. If the Court requests a brief in opposition, we will promptly file one.

<sup>1</sup> The caption names JPMorgan Chase & Co. and other entities that are defendants in an action pending in the Southern District of New York. (Wells Fargo is not a party to that action.) The petition before this Court involves a subpoena that Petitioner issued in the Northern District of California to seek discovery in support of the New York action. Wells Fargo successfully moved to quash the subpoena in the Northern District of California, and was the only appellee before the Ninth Circuit.
