I represent Petitioners Nazir Khan and Iftikhar Khan in this case. Under Supreme Court Rule 12.6, I write to inform the Court of Petitioners' belief that Respondents Hemosphere Inc., CryoLife Inc., Louis Elkins, Mark Grove, Javier Alvarez-Tostado, Siddarth Patel, Luis Sanchez, and Patrick Geraghty have no interest in the outcome of the petition for a writ of certiorari. The petition for a writ of certiorari challenges the Federal Circuit's affirmance of the district court's grant of Rule 11 sanctions against Petitioners.
