I am counsel of record for Merit Medical Systems, Inc. and 109 other related respondents in the above-referenced matter, as set forth in the waiver filed with the Court on December 8, 2020. We are in receipt of your January 26 letter requesting a response to the petition for a writ of certiorari by February 25, 2021.

Pursuant to Rule 30.4, we respectfully request that the time for filing the requested response be extended by 28 days, up to and including March 25, 2021. I and my colleague in this case, Mr. Brent Lorimer, have a number of professional obligations in other matters during the next few weeks, including briefing and discovery deadlines in *Bytedance, Ltd. et al. v.
