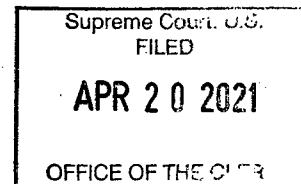

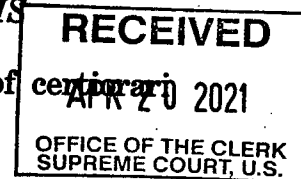



For question No. 10

I just wanted to bring to the Supreme Court's attention that I was not an indigent person before I was arrested. When I was arrested, the Government seized all my bank accounts, including some items and my property. I could not be able to have access of my bank accounts to hire or pay for attorney. A friend had helped to pay \$6000 to my first attorney Mr. Michiael G. Brucki. Because of the seize of my bank accounts, I could not be able to continue paying the money he asked for, so I dropped him out of the case.

Now, I have been depending on other people and begging for money before living my life in prison.
