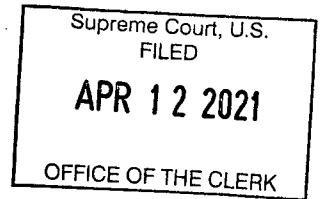

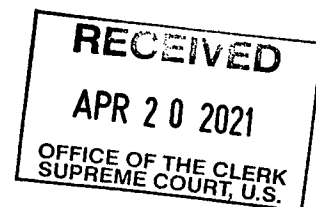

NO STATE SHALL MAKE OR ENFORCE ANY LAW WHICH SHALL WHICH SHALL ABRIDGE THE PRIVILEGES OR IMMUNITIES OF CITIZEN(S) OF THE UNITED STATES; NOR SHALL ANY STATE DEPRIVE ANY PERSON OF LIFE, LIBERTY OR PROPERTY WITHOUT DUE PROCESS OF LAW, NOR DENY TO ANY PERSON WITHIN ITS JURISDICTION THE EQUAL PROTECTION OF LAWS.
