PER CURIAM

ORDER

Aaron J. LaRose (“Movant”) appeals the denial of his Rule 29.15 motion for post-conviction relief after an evidentiary hearing on three of his thirty-one claims. A jury found Movant guilty of first-degree murder and armed criminal action. The trial court sentenced Movant to life imprisonment without parole on the first-degree murder conviction and thirty years’ imprisonment on the armed criminal action conviction, with both sentences to run consecutively. This Court affirmed Movant’s convictions and sentences on direct appeal in *State v. LaRose*, 412 S.W.3d 294 (Mo. App. E.D. 2013).

Following his direct appeal, Movant filed a Rule 29.15 motion, alleging thirty-one claims. The motion court held an evidentiary hearing on three claims and denied the remaining claims without an evidentiary hearing. Movant raises eleven points on appeal, contending the

motion court clearly erred denying the claims in his Rule 29.15 motion. In his first point, Movant contends trial counsel was ineffective for failing to object to the State's closing argument. In his second and third points, Movant argues trial counsel was ineffective for failing to admit certain video surveillance to dispute testimony presented in the State's case in chief about Movant's whereabouts on June 24, 2009. In his fourth point, Movant argues trial counsel was ineffective for stipulating to the chain of custody and admission of the State's video surveillance footage. In his fifth point, Movant contends trial counsel was ineffective for failing to object to several hearsay statements. In his sixth point, Movant asserts trial counsel was ineffective for failing to call a witness. In his seventh point, Movant argues trial counsel was ineffective for failing to elicit certain testimony from a witness on cross-examination. In his eighth through tenth points, Movant contends the State violated Rule 25.03 by failing to provide trial counsel with certain video surveillance, computer files and time tracking data, and information regarding the alleged ongoing criminal investigation of a State witness. Last, Movant argues the State knowingly elicited perjured testimony.

We have reviewed the briefs of the parties and the record on appeal and find the motion court did not clearly err in denying post-conviction relief. A written opinion would have no precedential value and would serve no jurisprudential purpose. The parties have been furnished with a memorandum, for their information only, setting forth the reasons for our decision.

We affirm the judgment under Missouri Supreme Court Rule 84.16(b)(2).
