This letter is written to this Court in regards to a letter I wrote on February 8, 2021 about my previous submission for a petition for a Writ of Certiorari (Exhibit A: Petitioner's Correspondence to the Court dated February 8, 2021).

On March 8, 2021, the Court responded to my inquiry and requested a copy of the judgment, which attached the latch and commenced a time toll, allowing for resubmission of my application within sixty (60) days (Exhibit B: Court's Correspondence to Petitioner dated March 8, 2021).


In response to your inquiry, I am seeking a Writ of Centiorari from the New York State Court of Appeal decision rendered on September 24, 2019 (Exhibit C: Decision and Order from the New York State Court of Appeals). My original petition for Writ of Centiorari was submitted to this Court on December 19, 2019. This was just shy of the ninety (90) days time limit set by statute (Exhibit D: Certificate of Service dated December 19,

2019; Inmate Disbursement Form submitted for Proof of Postage Payment dated December 19, 2019).

As stated in my previous correspondence to this Court, it is my understanding that a petition for a Writ of Centiorari was timely filed "if it is submitted within 90 days of the judgment from which the writ is sought (Penry v. Texas, 515 US 1304, 1304-05 [1995]). In such, I respectfully infer that the Court's determination, rendered on January 4, 2021, dismissing my application for a lack of jurisdiction may have been reached in error and requesta reconsideration of the matter at hand (Exhibit E: Court's Correspondence to Petitioner dated January 4, 2021). Petitioner hopes and prays to comply with this Court's rules and regulations, as well as your instructions. Petitioner believes all papers are in order as per your request.




