Petitioner, Jeremy Darnell Morton, respectfully request this Honorable Court, pursuant to Supreme Court Rule 39, for leave to proceed *in forma pauperis* so that he may file the accompanying Petition for Writ of Certiorari with this Court.


The Petitioner appeals his conviction and sentence to 262 months of imprisonment. The Petitioner has been incarcerated since 2015, initially on various criminal charges out of the state of Michigan, and since 2019, on charges out of the United States District Court for the Western District of Michigan. The Petitioner is indigent and currently in the custody of the United States Bureau of Prisons serving a lengthy prison term where he is not receiving any income.

Petitioner was found to be indigent by the district court. The district court appointed the Federal Public Defender to represent Petitioner. Appendix A. The public defender represented the Petitioner at trial and initially on appeal before Petitioner's family retained counsel. Retained counsel was not interested in filing a petition with the Court so Petitioner's family retained the undersigned for the sole purpose of filing the Petition for Writ of Certiorari with this Court.

The undersigned is admitted to practice in the Court and was sworn in on January 19, 2016. Because the Petitioner has been incarcerated for more than five years and has no income, he is indigent and requests to proceed *in forma pauperis*.
